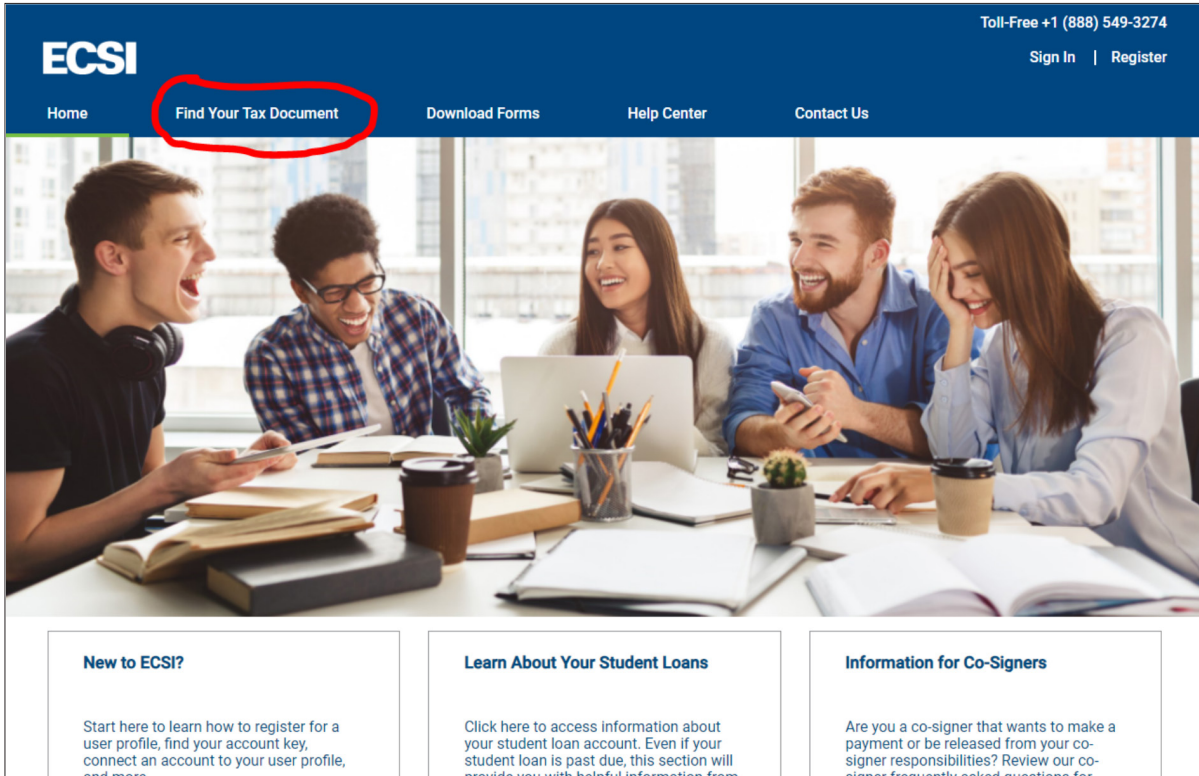


How to Access 1098-T Online

1. Go to ECSI website at <https://heartland.ecsi.net>.
2. Scroll down towards the bottom of the page, then click “Find Your Tax Documents.”



3. You will have to sign in or create an ECSI profile.

If you signed up to receive your tax form electronically (completed the electronic consent application) prior to receiving your tax form, your Heartland Account Number will be located in the email communication you received from ECSI on behalf of your school.
